Description of content:</b> According to the announcement of the Government Gazette dated 21 April 2021, the suspension for importation of live poultry and poultry carcasses from Viet Nam has expired on 20 July 2021. However, the OIE has reported a continued outbreak of Highly Pathogenic Avian Influenza (HPAI) in area of Viet Nam. Therefore, it is necessary for Thailand to prevent the entry of Highly Pathogenic Avian Influenza (HPAI) disease into the country. By the virtue of Animal Epidemics Act B.E. 2558 (2015), the importation of live poultry and poultry carcasses from Viet Nam is temporarily suspended for a period of 90 days after publication in the Thai Royal Gazette (20 July 2021).
