#### Standards for Pesticide Residue Limits in Animal Products

The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu proposed amendments to the Standards for Pesticide Residue Limits in Foods and Standards for Pesticide Residue Limits in Animal Products dated 17 January 2020 (G/SPS/N/TPKM/518) and 15 February 2020 (G/SPS/N/TPKM/520). The final amendment entered into force on 20 May 2020.
