Addendum

The following communication, received on 19 September 2022, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Hexythiazox

The proposed maximum residue limit (PMRL) document for hexythiazox notified in G/SPS/N/CAN/1442 (dated 24 June 2022) was adopted 14 September 2022. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

15 Tea (dried leaves)

¹ ppm = parts per million
